- 1. In case of inter-island shipment of animals, test requirements shall be required based on DA AO No.13 series of 2012 re: Guidelines on the Transport/Shipment of Hogs, Cattle, Carabao, Sheep and Goats and other Cloven Footed Animals in and between Luzon, VIsayas and Mindanao.
- 2. As per Manual of Standards for Diagnostic Test and Vaccines of the World Organization of Animal Health (OIE) sampling size would be the following
  - 10-15 heads 100% samples
  - 16-49 heads 15 samples
  - 50-299 heads- 20 samples
  - 300 and more- 30 samples

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from *Department of Agriculture Regional Field Office No. 5* and inspect the Bidding Documents at the address given below during *Mondays Fridays*, 8:00 AM to 5:00 PM.
- 5. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Department of Agriculture Regional Field Office No. 5* will hold a Pre-Bid Conference on *October 31, 2018; 9:30AM* at DA Library, Research Building, DA RFO-5, San Agustin, Pili, Camarines Sur, which shall be open to prospective bidders.
