**I. Business Matters**

The presiding officer BAC Vice Chairperson Rosita M. Imperial called the meeting to order at 9:30 AM. The Chair declared a quorum.

**I. PRE-BIDDING CONFERENCE (as reset from September 10)**

**Project Title:**

1. (2nd Invitation) Supply and delivery of Laboratory Supplies for use of ILD, RSL, RAFAL, RCPC

ABC – Php 559,650.00

The Chair acknowledged the presence of the two bidders;

1. Cristora Enterprise Enterprises
2. Lifeline Diagnostics Supplies Inc.

BAC Secretariat presented the technical specification of the items to be bided for information, clarification and finalization.

The representative from Lifeline Diagnostics Supplies Inc. asked if the bid covers all items. A BAC Member answered that the offer, if would not cover the items on the lot would render it ineligible. Bid offer should be for the whole lot. No partial bid is allowed. The end user also added that some line items are procured by pair or as a set and cannot be delivered separately.

The representative from Cristora Enterprise said that they are willing to research on the availability of the items.

**Title Project:**

2. (2nd Invitation) Supply and delivery of Chemical and Filtering Supplies

ABC – Php 1,543,906.00

The Chair acknowledged the presence of the two bidders;

1. Cristora Enterprise Enterprises
2. Lifeline Diagnostics Supplies Inc.

BAC Secretariat presented the technical specification of the items to be bided for information, clarification and finalization.

Same concerns as the previous item were raised regarding the partial bid. A BAC Member answered that the same bid offer for lot would apply.

**II. PRE BIDDING CONFERENCE**

**Project Title:**

1. (2nd Invitation) Supply and delivery of 8 units Corn Mill under 2018 Corn program

ABC – Php 1,880,000.00

The Chair acknowledged the bidders for the items;

1. All Certified Equipment Training Corp. (ACETC)
2. GRJC Agri Industrial Machineries

BAC Secretariat presented the technical specification of the items to be bided for information, clarification and finalization.

Representative from GRJC Agri Industrial Machineries asked for the period for submission of AMTEC Test result as requirement during post qua. A BAC Member clarified that the period should be within thirty days unless otherwise provided by RAED.

Representative from ACETC also asked whether there is a strict compliance for the bid item's capacity of 180 kl. per hour, and if they may offer for as low as 100 kl. per hour. The end user answered that they would review first and the information would be included in the bid bulletin.


The BAC Secretariat is instructed to release the bid bulletin seven days before the date of bid opening. The date of bid opening is scheduled on September 26, 2018.
