

## REQUEST TO SUBMIT QUOTATION FOR THE SUPPLY AND DELIVERY OF OTHER SUPPLIES AND EQUIPMENT FOR USE AT BAC AND OTHER END-USERS AT APPROVED BUDGET FOR THE CONTRACT AMOUNTING TO ONE HUNDRED SIXTY FOUR THOUSAND THREE HUNDRED FORTY TWO PESOS (PHP164,342.00) PURSUANT TO ALTERNATIVE METHOD OF PROCUREMENT SPECIFICALLY NEGOTIATED PROCUREMENT – SHOPPING UNDER SECTION 52.1 UNDER RA 9184 AND ITS REVISED IRR.
