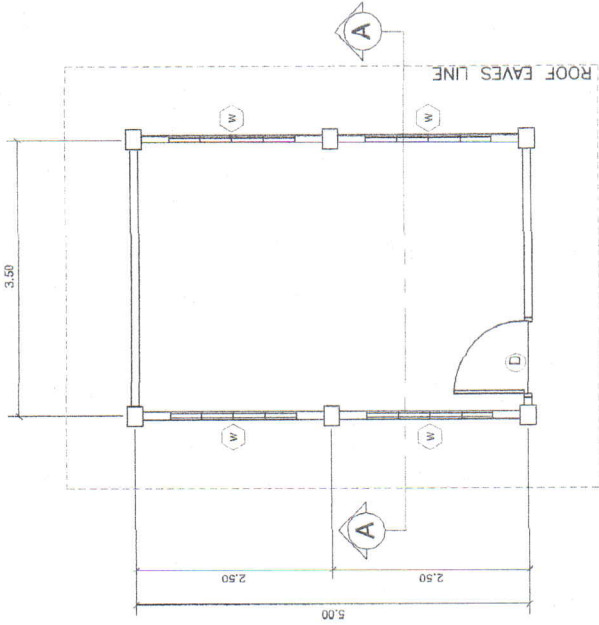

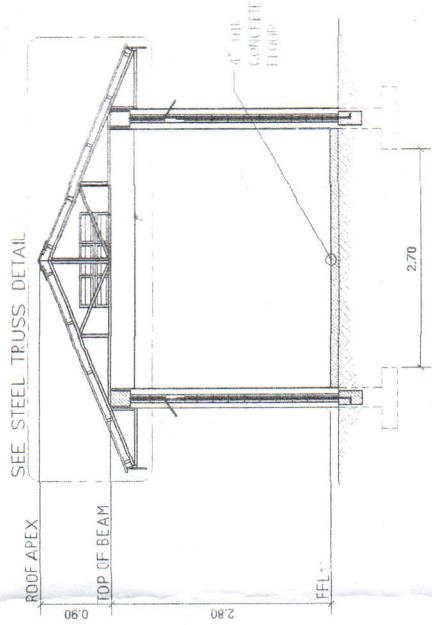

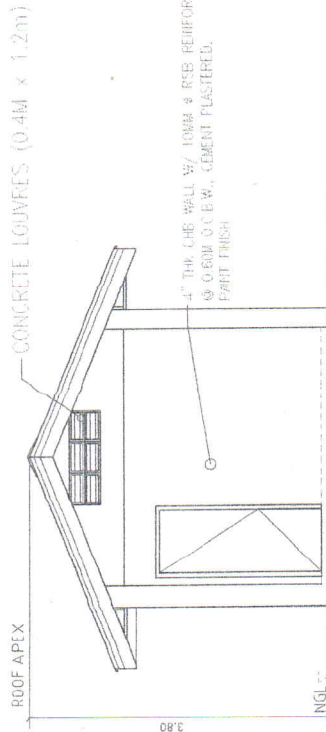

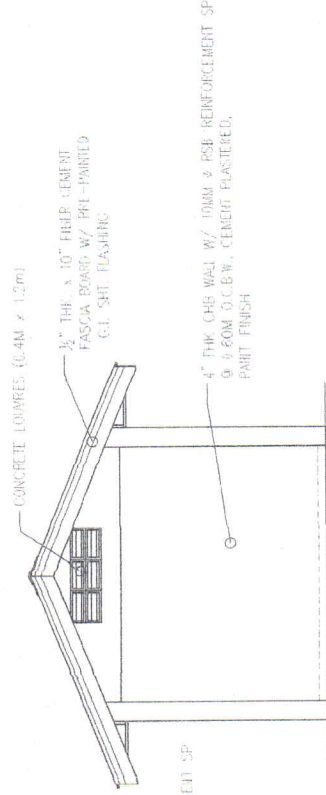
FLOOR PLAN
SCALE: 1:75 MTS.



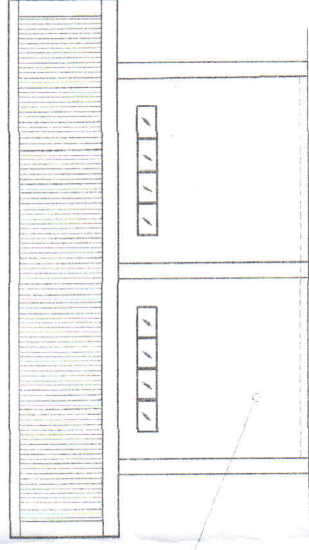
SECTION THRU A-A

SCALE: 1:75 MTS.

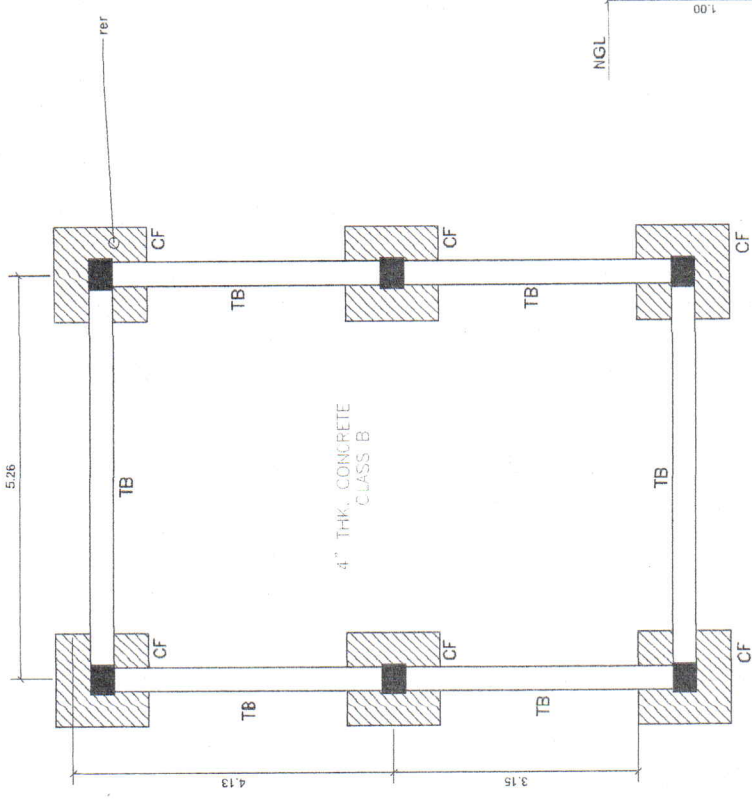


REAR ELEVATION

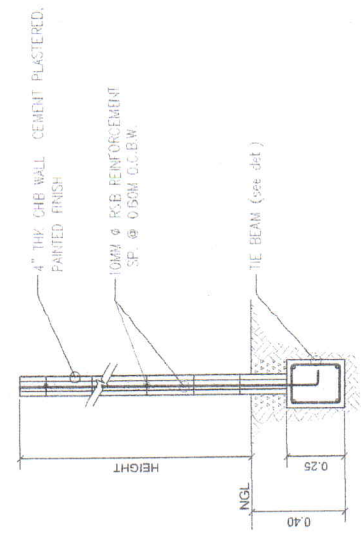


TYP. SIDE ELEVATION

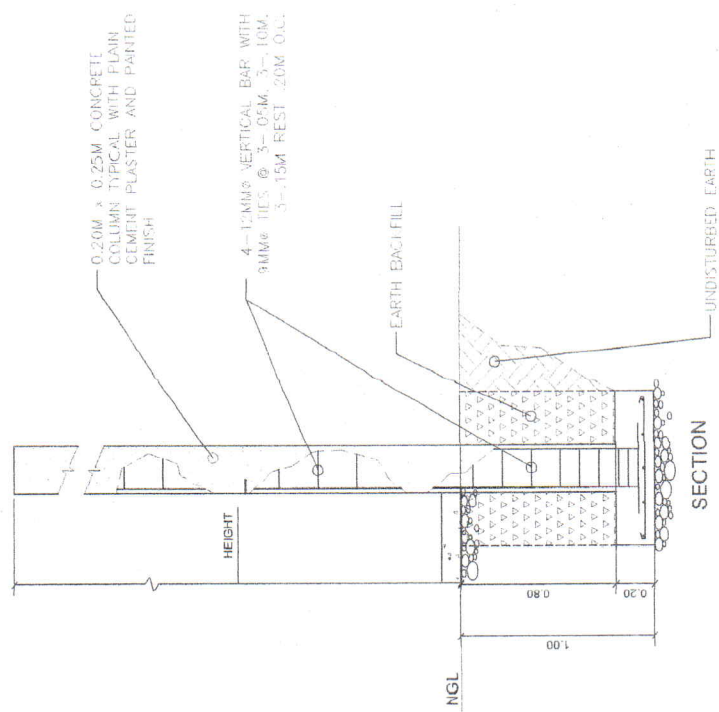

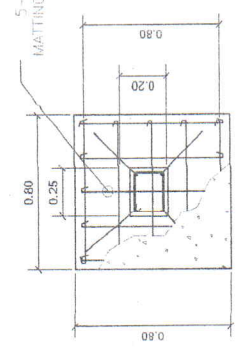
FOUNDATION LAYOUT

NOT TO SCALE

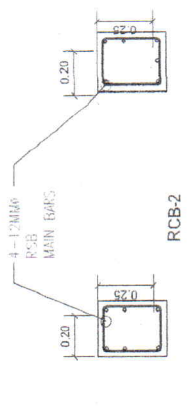

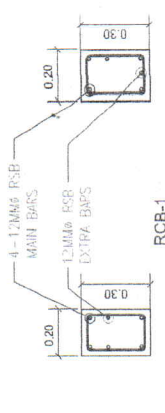
PLAN

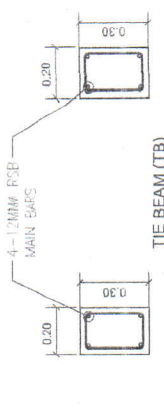
RCB-2 @ SUPPORT @ MIDSPAN

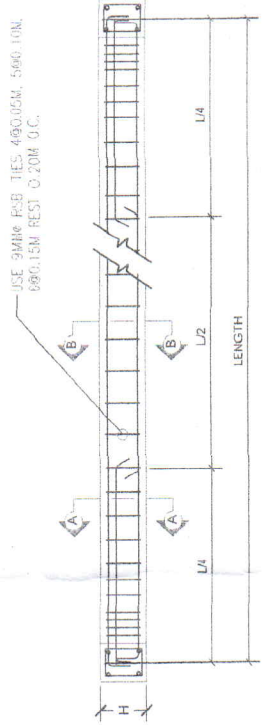
RCB-1 @ SUPPORT @ MIDSPAN
