RESOLUTION RECOMMENDING PROCUREMENT OF ADDITIONAL GARDEN TOOLS UNDER QUICK RESPONSE FUND (QRF) 2021 FOR THE TOTAL AMOUNT OF TWO MILLION FIFTY NINE THOUSAND SIX HUNDRED NINETY NINE PESOS (PHP2,059,600.00) THRU REPEAT ORDER UNDER ALTERNATIVE METHODS OF PROCUREMENT, SECTION 51 OF RA 9184 AND ITS REVISED IRR.

WHEREAS, the Department of Agriculture Regional Field Office No. 5, through the Bids and Awards Committee (BAC), procured Lot 1 - Various Agricultural Supplies for distribution to Farmers Beneficiaries affected by Typhoon Quinta, Rolly and Ulysses (QRF) 2021 thru Public Bidding with the Approved Budget for the Contract (ABC) amounting to Php12,237,000.00;

WHEREAS, after the completion of the bidding process and awarding of the contract, the Bids and Awards Committee (BAC) received a letter from the end user stating for urgency to purchase additional Garden Tools thru Repeat as contained in the letter dated December 28, 2021 and was received by the BAC office last December 29, 2021;

WHEREAS, after the Bids and Awards Committee (BAC) was convened, the members have unanimously agreed to recommend for the conduct of Repeat Order for the procurement of additional Garden Tools which fund shall be taken from Quick Response Fund (QRF) 2021;

WHEREAS, Section 51 of the revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the Government Procurement Act, allows the resort to Repeat Order subject to conditions required by law;

WHEREAS, the Bids and Awards Committee (BAC) sees it proper to conduct Repeat Order of additional Garden Tools under Quick Response Fund (QRF) 2021 due to the urgent need of the DA Regional Office;

WHEREAS, the conduct of Repeat Order for additional procurement is proper and justified;

Now, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a. To recommend further procurement of Garden Tools under Quick Response Fund (QRF) 2021;
- b. To recommend for the conduct of Repeat Order for the procurement of Assorted Garden Tools;

RESOLVED FURTHER that copies of this Resolution be presented to the Regional Executive Director for his appropriate action and approval, when approved, let Notice to Conduct Repeat Order be posted in the DA website and appropriate contract be immediately executed to expedite the implementation of the project in the interest of service. Let copies of the approved Resolution be furnished to concerned offices for their reference and information.
