The Department of Agriculture Regional Field Office No. 5 (DA RFO 5), San Agustin, Pili, Camarines Sur is inviting interested contractors to submit complete bid quotation for the Labor and Materials for the Water Proofing of Admin Building Roof Deck at DA RFO 5, San Agustin, Pili Camarines Sur
