[SVP-149-22] REQUEST TO SUBMIT QUOTATION OR PROPOSAL FOR THE LABOR AND MATERIALS FOR THE REPAIR OF DAMAGED TILES AT COA OFFICE (RESIDENT AUDITOR'S ROOM) AT APPROVED BUDGET FOR THE CONTRACT AMOUNTING TO THIRTY FIVE THOUSAND PESOS (PHP35,000.00) PURSUANT TO ALTERNATIVE METHOD OF PROCUREMENT SPECIFICALLY NEGOTIATED PROCUREMENT-SMALL VALUE PROCUREMENT UNDER SECTION 53.9 UNDER RA 9184 AND ITS REVISED IRR.

The Department of Agriculture Regional Field Office No. 5 (DA RFO 5), San Agustin, Pili, Camarines Sur is inviting interested contractors to submit complete bid quotation for the Labor and Materials for the Repair of damaged tiles at COA Office Resident Auditor's Room.

The agency intends to apply the amount Thirty-Five Thousand Pesos (Php35,000.00) as the Approved Budget for the Contract.

As per approved Purchase Request and considering the nature of requisition being not more than One Million Pesos (Php1,000,000.00) and in order to fast-track the implementation of the program, this procurement is facilitated thru Negotiated Procurement-Small Value Procurement under Section 53.9 of RA 9184 and its Revised IRR.
