The Department of Agriculture Regional Field Office No. 5 (DA RFO 5), San Agustin, Pili, Camarines Sur is inviting interested contractors to submit complete bid quotation for the LABOR AND MATERIALS FOR REPAIR AND IMPROVEMENT OF SWINE PRODUCTION FACILITY AT ARDC CABANGAN, CAMALIG, ALBAY.
