The Department of Agriculture Regional Field Office No. 5 (DA RFO 5), San Agustin, Pili, Camarines Sur is inviting interested suppliers to submit complete quotation for LABOR AND MATERIALS FOR THE REPAINTING OF EXTERIOR WALL OF FARMERS HALL UNDER 2022 HVCDP. The agency intends to apply the amount of SEVENTY-EIGHT THOUSAND PESOS (PHP 78,000.00) as the Approved Budget for the Contract.
