The Department of Agriculture Regional Field Office No. 5 (DA RFO 5), San Agustin, Pili, Camarines Sur is inviting interested suppliers to submit complete bid proposal for the Procurement of Diesel for Implementation of CFIDP under HVCDP 2023. The agency intends to apply the amount **One Hundred Thousand Pesos (Php100,000.00)** as the Approved Budget for the Contract.
