

3. 4 copies of any proof of eligibility-report of rating, license, eligibility/eligibility card (original copy, authenticated copy, scanned copy, or site/ screen capture of the eligibility using Civil Service Eligibility Verification System, Professional Regulation Commission's (PRC)'s Licensure Examination and Registration Information System (LERIS) for original appointment and promotion, transfer, reappointment (change of status to permanent) or reemployment.
