








LOCATION MAP

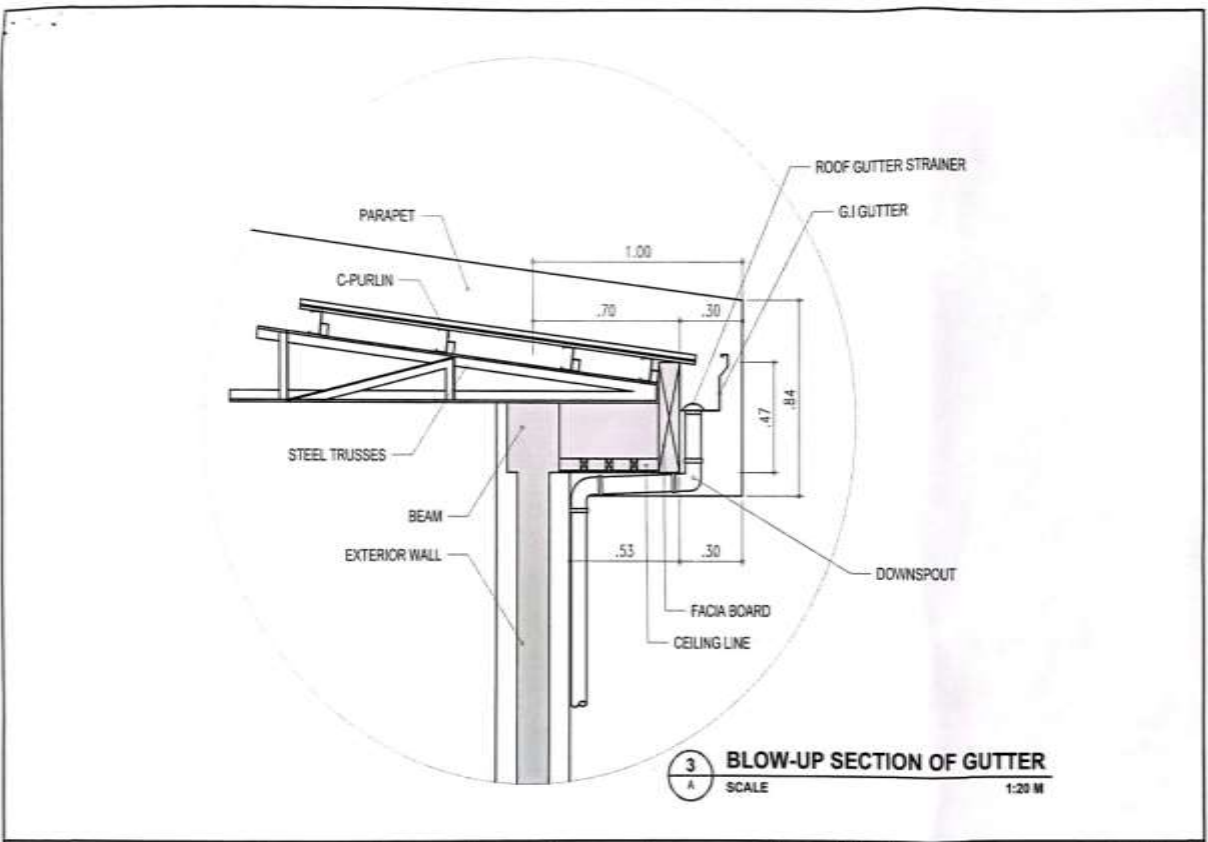
